## SCHEDULE B TO THE RETAIL ELECTRIC SUPPLIER AGREEMENT BETWEEN MIDAMERICAN AND KANE (COUNTY OF) IL ENERGY SERVICES - FIXED/VARIABLE SUPPLY PRICE

DATE: October 14, 2008

Customer will be billed an amount corresponding to the time period set forth below ("Pricing Period") applied to all the Customer's electric energy usage at its properties as listed on Schedule A. During seasonal changes between Pricing Periods, Customer's usage will be prorated based on actual interval data (if available) or average daily usage (including on-peak and off-peak periods). The Fixed Price for the corresponding Pricing Period will then be applied. The transition between Fixed Price and the Variable Price will become effective with the meter read date applicable to the bill month.

ON-PEAK/OFF-PEAK FIXED PRICE. If Customer elects an On-Peak and Off-Peak Fixed Price, the on-peak and off-peak kWh will be determined using the guidelines set forth in the ComEd delivery tariff. On-peak and off-peak energy usage for Customer's non-interval meters, if any, will be determined by scaling monthly usage to the applicable class profile. MidAmerican may estimate peak and off-peak usage in the event of metering equipment malfunctions.

SEASONAL FIXED PRICE. If Customer does not elect an On-Peak/Off-Peak Fixed Price, the Seasonal Fixed Price will be applied to all usage within the respective Pricing Period.

**VARIABLE PRICE.** The Variable Price per kWh for Hourly Energy Usage shall be the associated hourly PJM ComEd Zone Day Ahead Locational Marginal Price (LMP) (in \$/kWh).

- Ancillary charge includes all costs for ancillary services as required under the applicable tariffs and operating services
  agreements with PJM or the local utility company.
- Capacity charge will be assessed based on the PJM Locational Reliability Charge and MidAmerican's incurred costs.
- Line Losses will be based on the combined transmission and delivery tariffed loss factors applied to the Fixed Price and/or Variable Price for each account separately.
- Delivery charges, as assigned by the delivery company, applicable to Customer's properties, including but not limited to
  monthly customer charges, facilities, meter or equipment charges, transition charges, taxes, nuclear decommissioning costs,
  public purpose program costs, environmental program compliance costs and riders.

Referencing the items listed above (Transmission, Ancillary, Capacity, Line Losses, and Delivery) any change in business practice, market based ancillary or applicable delivery or transmission tariff that affects the charges as defined in this Schedule B, excluding Fixed Prices, may be incorporated herein as of the effective date on which the change occurs or thereafter

**HOURLY ENERGY USAGE.** All electric energy in kWh consumed each hour at the Customer's properties. Hourly Energy Usage for Customer's non-interval meters, if any, will be determined by scaling monthly usage to the applicable class profile. Hourly Energy Usage for non-interval meters, if any, will be added to hourly usage recorded by Customer's interval meters to determine total Hourly Energy Usage at the Customer's properties. MidAmerican may estimate Hourly Energy Usage in the event of metering equipment malfunctions.

#### SCHEDULE B TO THE RETAIL ELECTRIC SUPPLIER AGREEMENT BETWEEN MIDAMERICAN AND KANE (COUNTY ENERGY SERVICES - FIXED/VARIABLE SUPPLY PRICE

CONVERSION TO FIXED PRICING. Customer has the option to convert, one time during a given Pricing Period, the Variable Price above to Fixed Price at all the properties listed on Schedule A. To exercise this option, both parties must execute a Revised Schedule B at least 10 days prior to Customer's earliest normal delivery company meter reading date for all properties.

This Designation of General Account Agent shall be valid until Customer or General Account Agent provides ComEd with written notice of its termination or until this Designation is otherwise terminated in accordance with ComEd's tariffs.

The designation or use of a General Account Agent does not affect Customer's responsibilities to timely pay ComEd all amounts due and perform and satisfy all other obligations applicable to Customer.

Customer shall remain liable to timely pay ComEd for all balances due for services rendered by ComEd and all other balances owed ComEd, even if General Account Agent fails to remit to ComEd amounts paid by Customer to General Account Agent for remittance to ComEd. Customer shall be responsible to protect its interests with General Account Agent. The appointment of General Account Agent shall not give Customer or General Account Agent any additional rights beyond those Customer would have under ComEd's tariffs and any agreements between ComEd and Customer. ComEd shall not be required to perform services for General Account Agent as agent of Customer that ComEd does not perform for Customer.
