

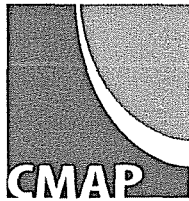

Agreement Amendment #1

Contract No. **C-10-0015**

Effective May 8, 2009, an agreement was entered into between the Chicago Metropolitan Agency for Planning, (CMAP), and the County of Kane, (COUNTY) acting on behalf of the staff of the Kane/Kendall Council of Mayors, (COM). The agreement is for grant assistance for Full Circle projects.

All other terms and conditions of the agreement entered into on May 8, 2009 are in full force with the exception of the above listed amendment.

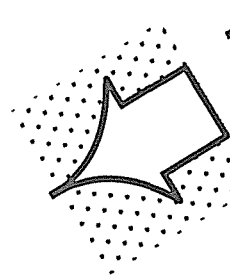
