Notes:

1. **Entire segments must be leased.** For example, if licensee only requires 5 linear miles within segment # 11 Randall Road North to ECC, you must license the entire 10.8-mile segment.
2. Only fiber pairs / 2 fibers will be licensed.
3. The 4 -year fiber cost is due in year 1 of the license. Year 3 – 4 include maintenance and administrative costs. Table 1 does not include any construction, splicing, cross connects.
4. All Kane County fiber interconnect, vault access, signal maintenance, splicing, repairs, and testing are to be performed by Kane County's authorized vendor.
5. Maintenance fees increase 4% per year and Administration fees increase 3% per year.

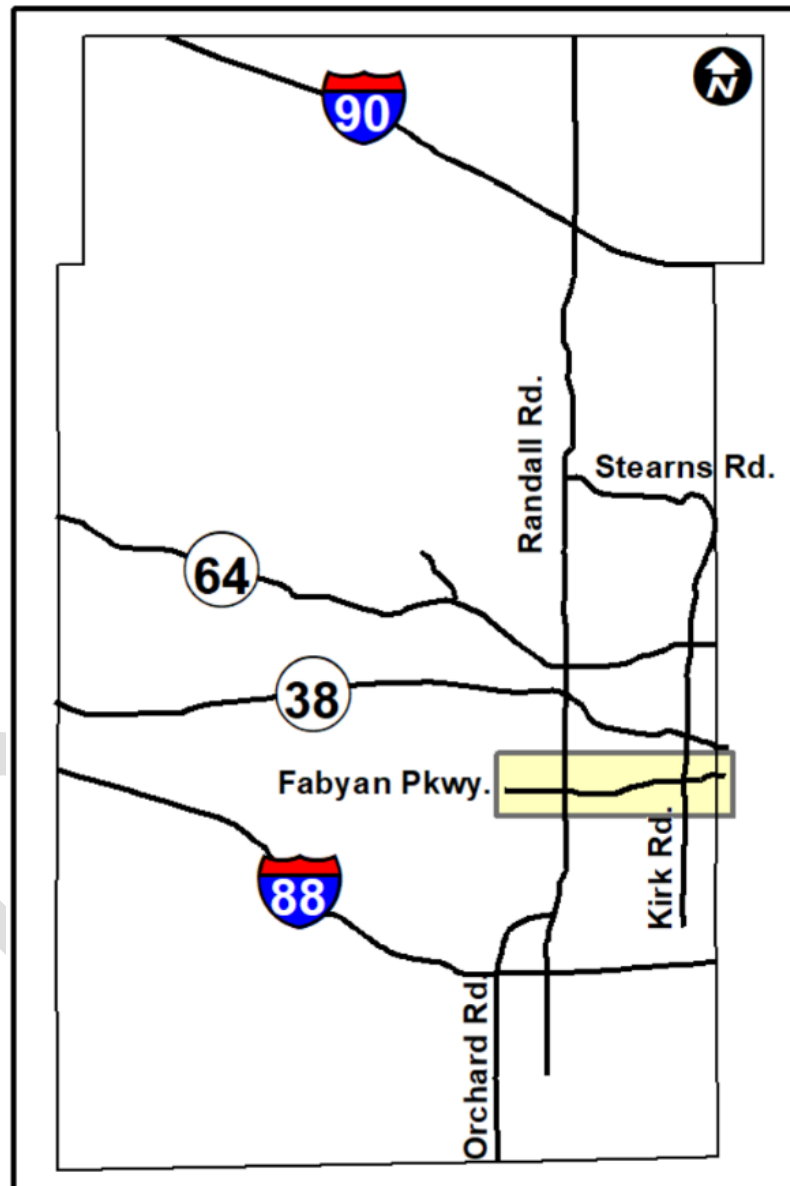

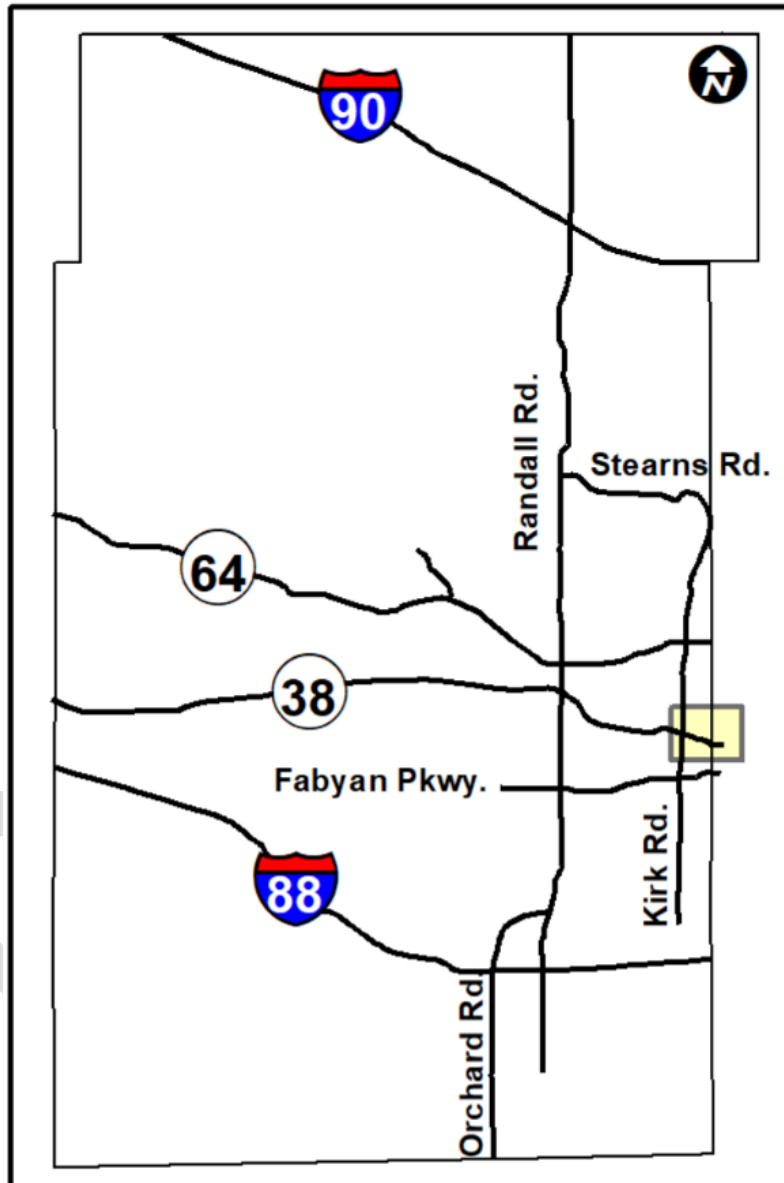
#1 - Fabyan Parkway

General location: From the intersection of Fabyan Parkway and Randall Road proceeding East to the intersection of Fabyan Parkway and Technology Boulevard.



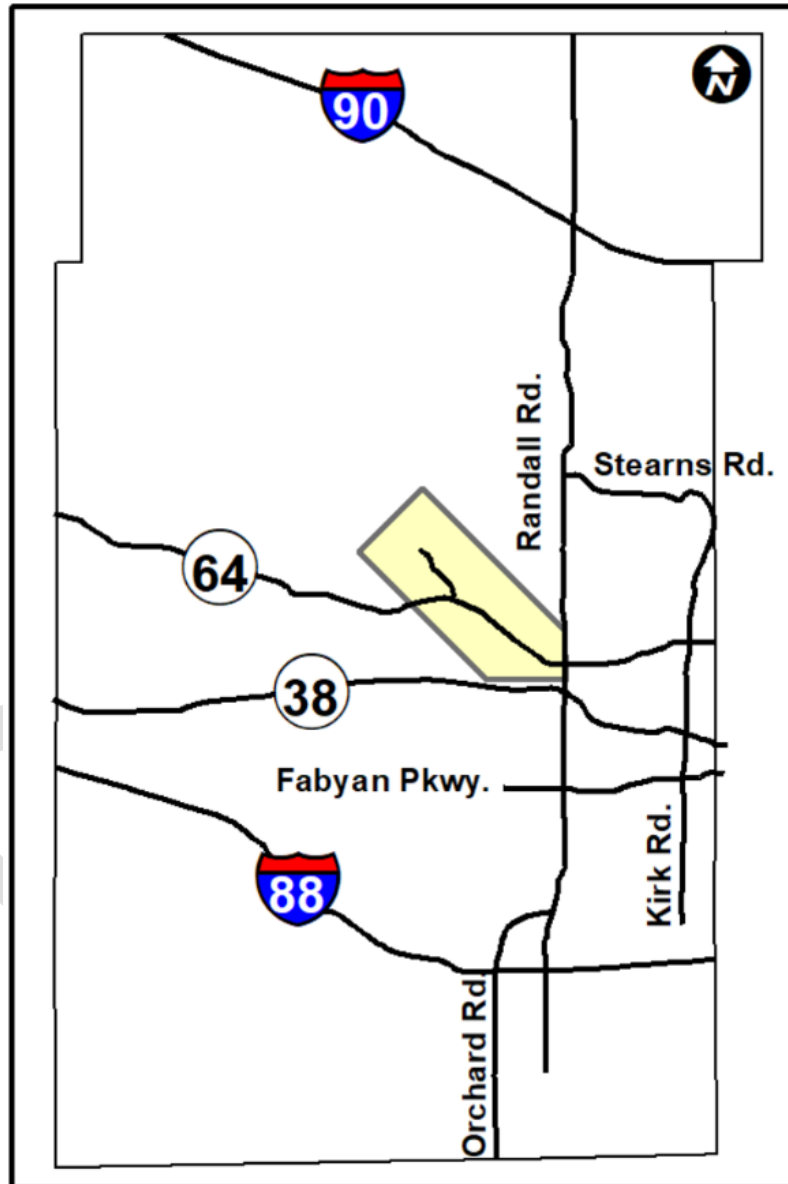
#2 -IL Route 38

General location: From the intersection of IL 38 and Kirk Road proceeding East to the intersection of IL 38 Technology Boulevard.



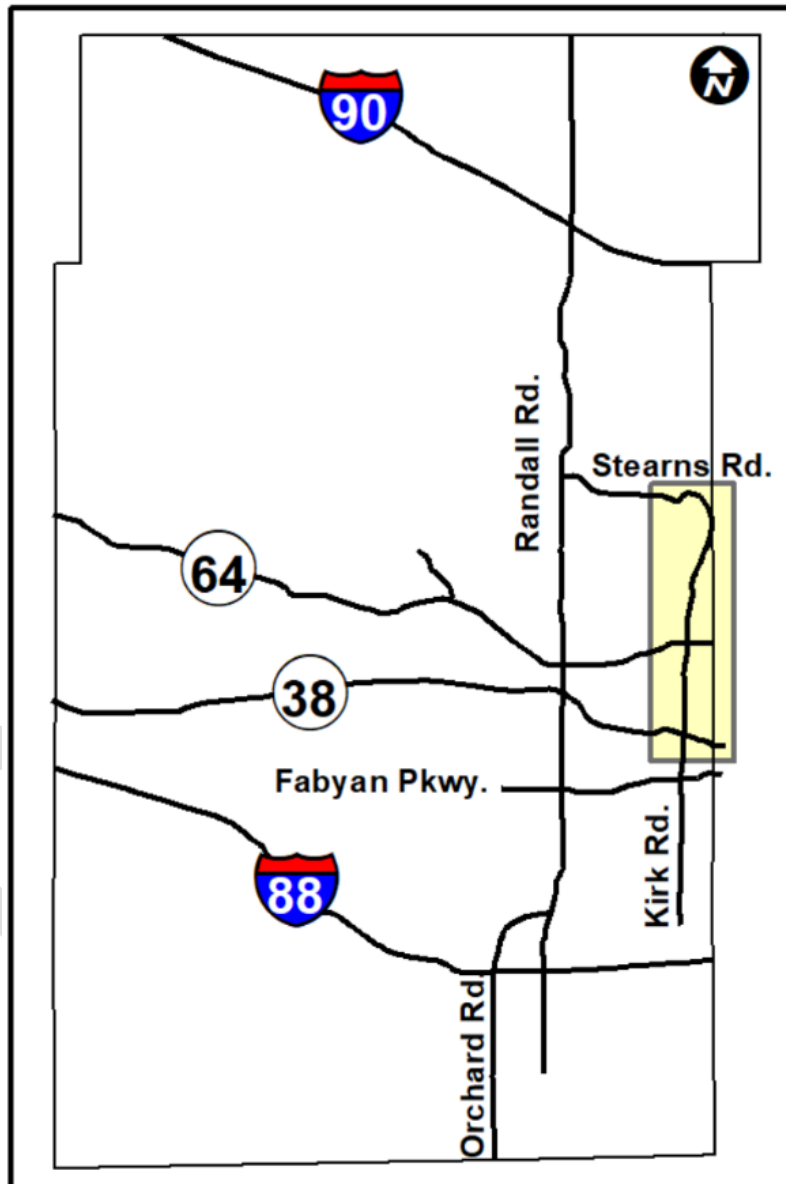
#3 - IL Route 64 and Burlington Road

General location: From the intersection of IL Route 64 and Randall Road proceeding West to the intersection of IL Route 64 and Burlington Road proceeding North on Burlington Road to the intersection of Burlington Road and Empire Road.



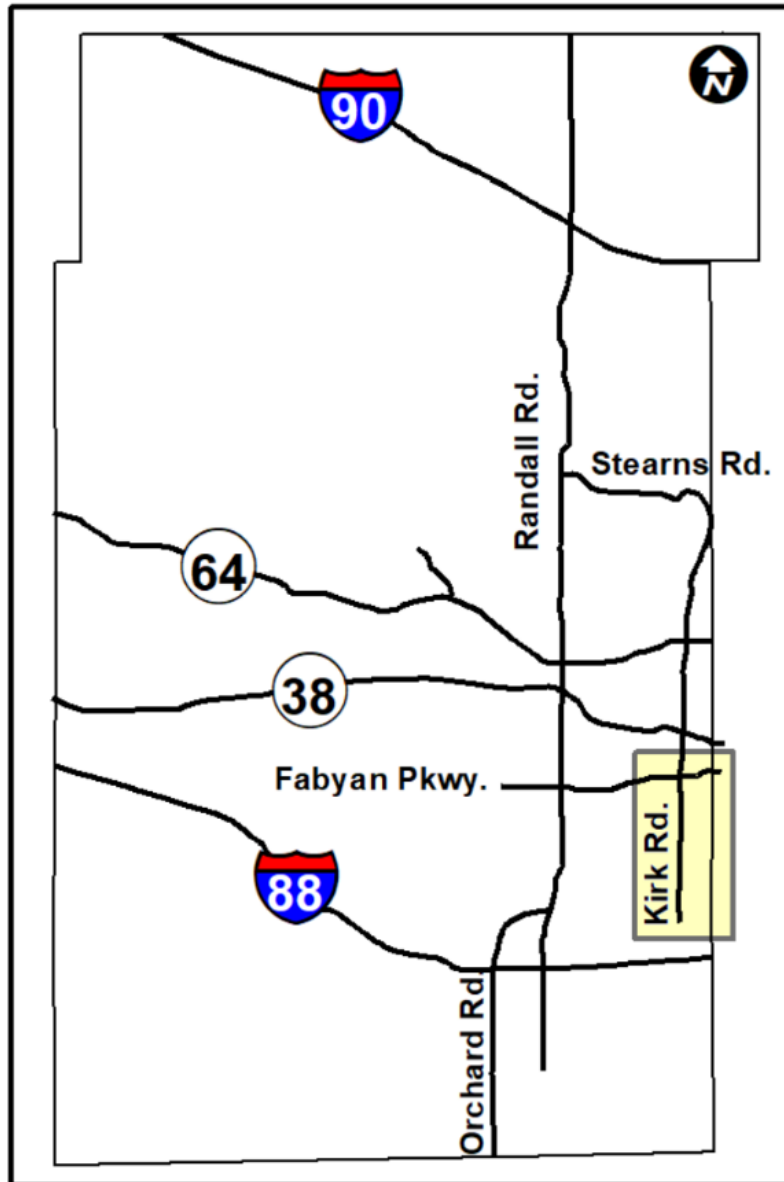
#4 - Kirk Road North

General location: From the intersection of Kirk Road and IL 38 proceeding North to the intersection of Kirk Road and Dunham Road proceeding North to the intersection of Dunham Road and Stearns Road.



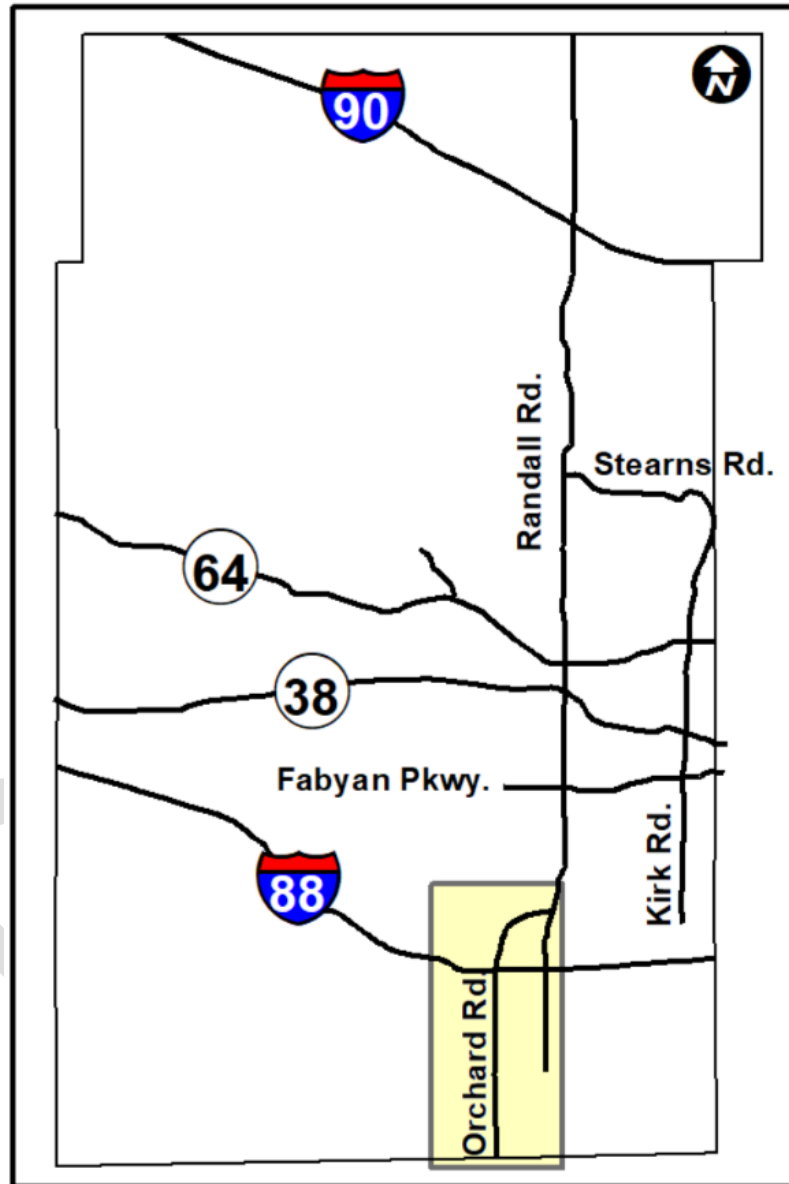
#5 - Kirk Road South

General location: From the intersection of Kirk Road and Butterfield Road proceeding North to the intersection of Kirk Road and Fabyan Parkway.



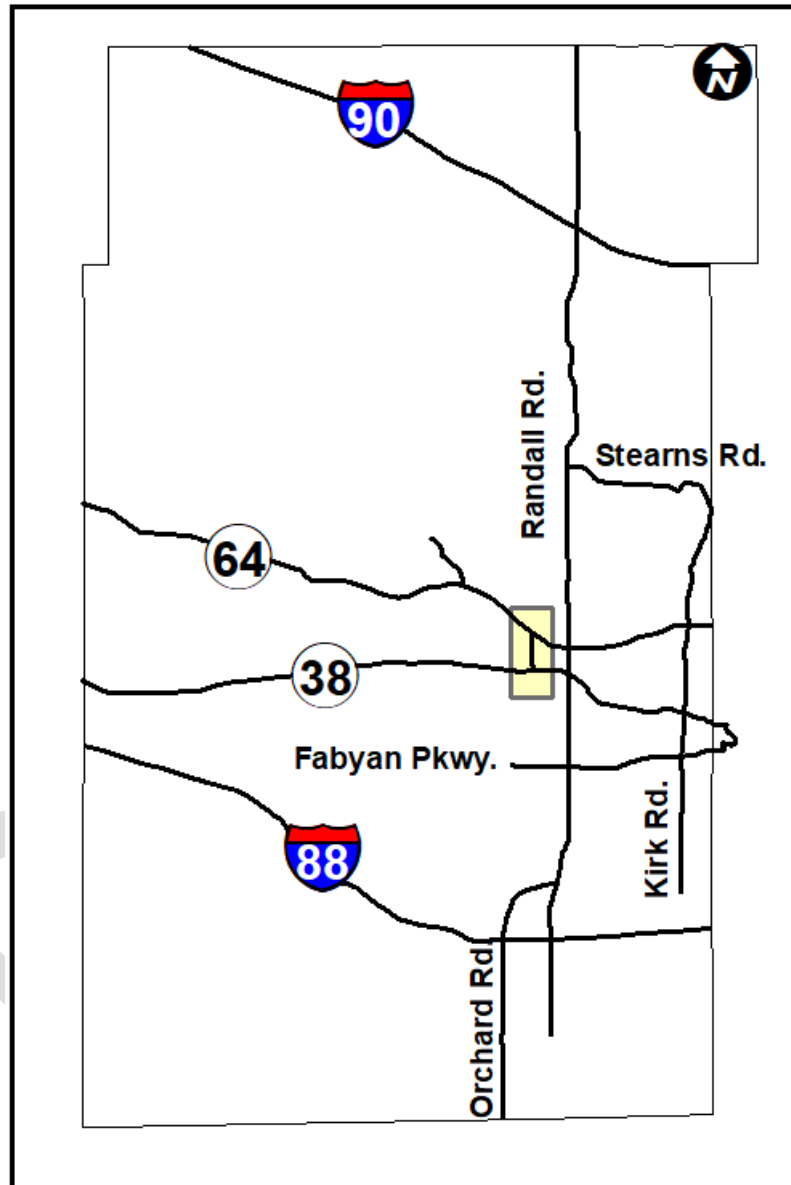
#6 - Orchard Road

General location: From the intersection of Orchard Road and Jericho Road Proceeding North to the intersection of Orchard Road and Randall Road.



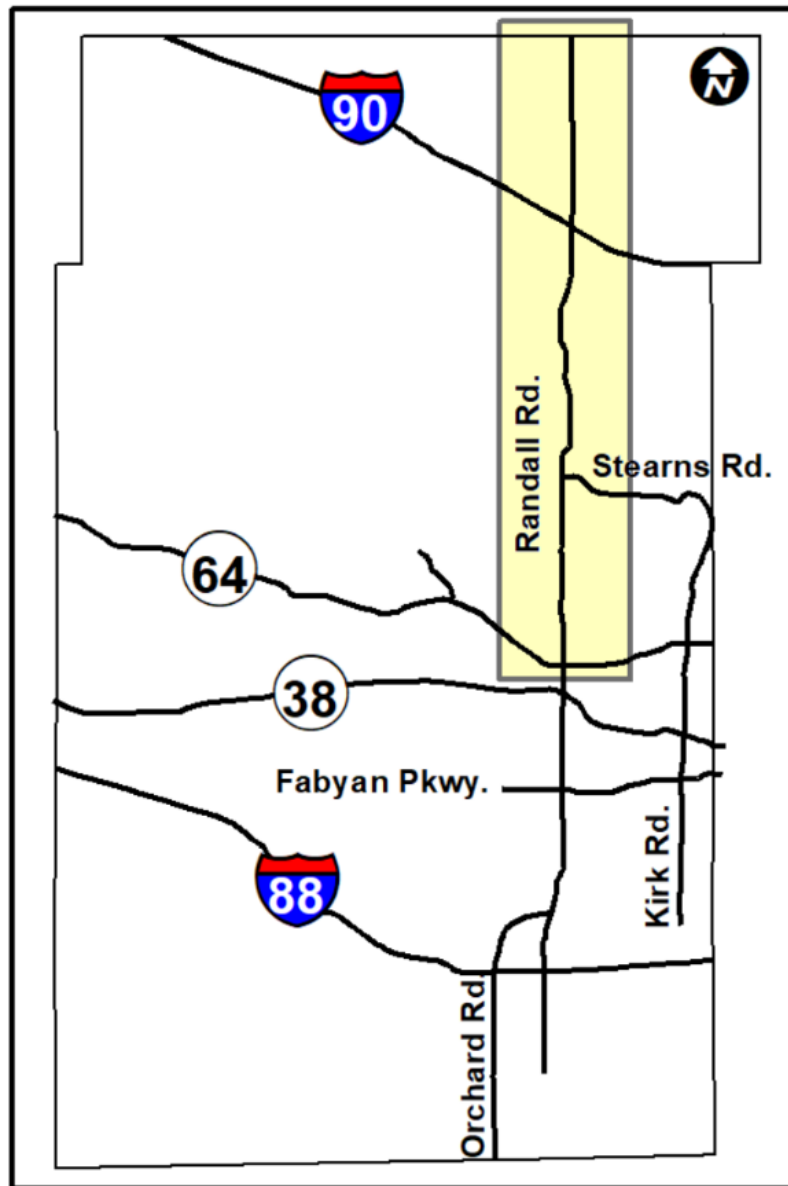
#7 - Peck Road

General location: From the intersection of Peck Road and IL 64 to the intersection of Peck Road and IL 38.



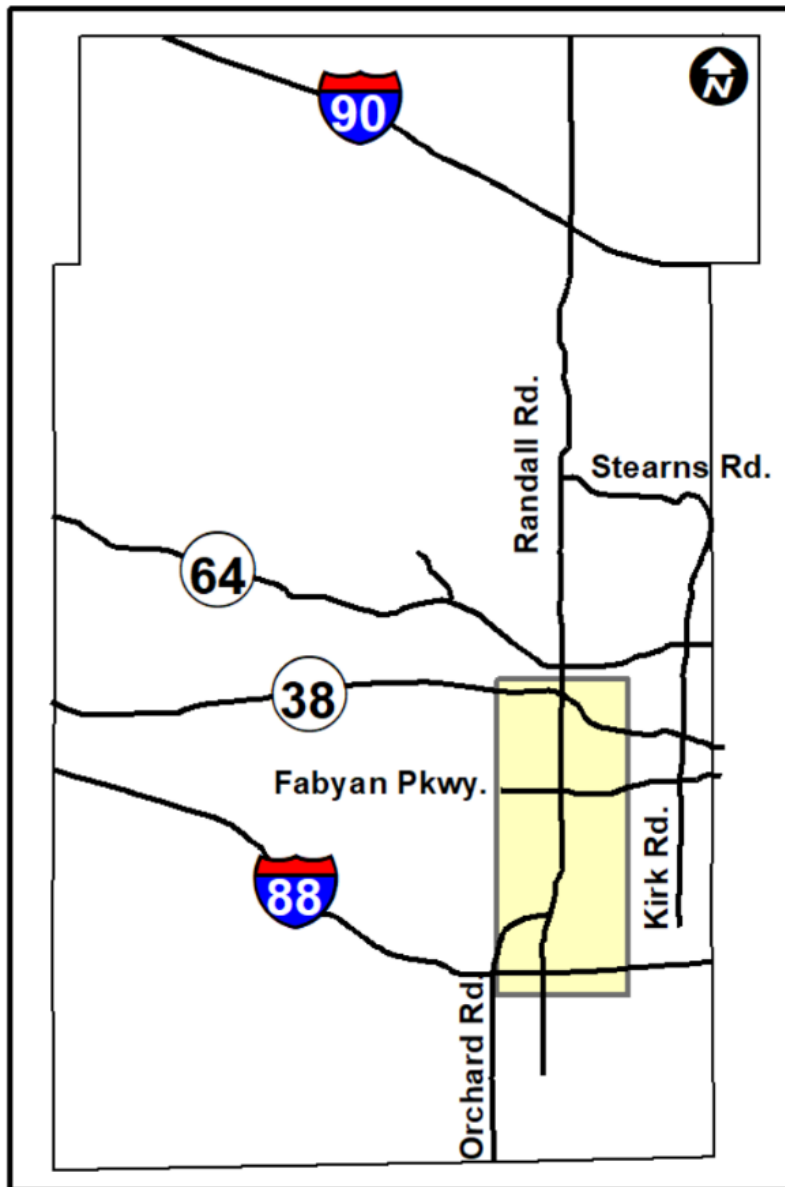
#8 - Randall Road North

General location: From Randall Road adjacent to the Kane County Circuit Court Offices (530 South Randall Road, St. Charles, IL 60174) proceeding North to the intersection of Randall Road and County Line Road.



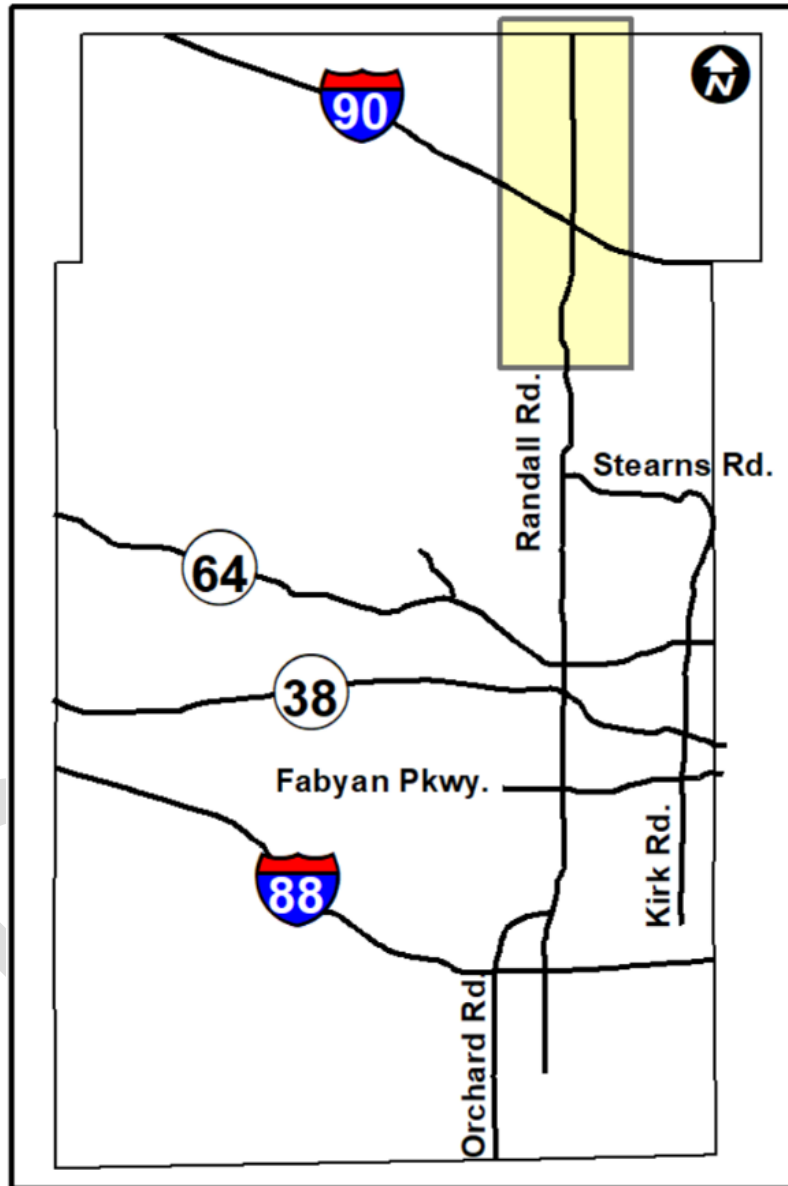
#9 - Randall Road South

General location: From the intersection of Randall Road and Orchard Road proceeding North on Randall Road adjacent to the Kane County Circuit Court Offices (530 South Randall Road, St. Charles, IL 60174).



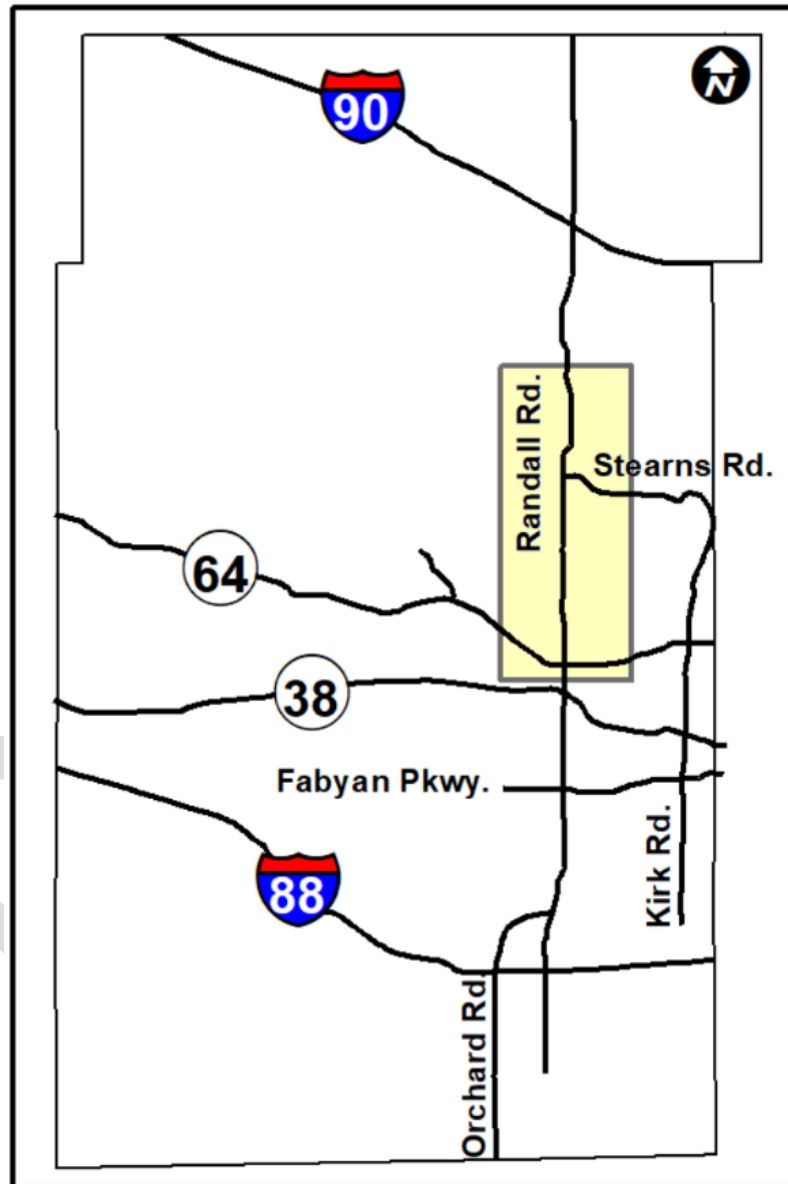
#10 - Randall Road North ECC to North County Line

General location: From the intersection of Randall Road and Spartan Drive proceeding North to the intersection of Randall Road and County Line Road.



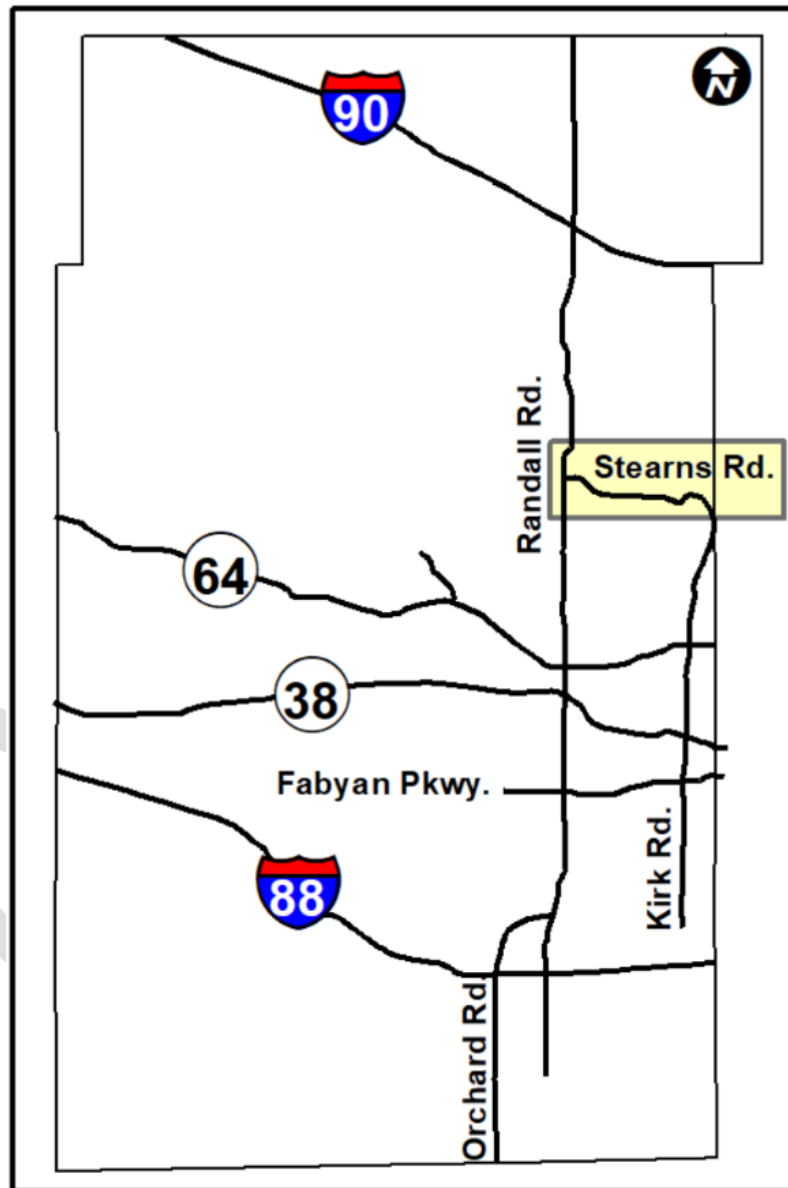
11 -Randall Road North to ECC

General location: From Randall Road adjacent to the Kane County Circuit Court Offices (530 South Randall Road, St. Charles, IL 60174) proceeding North to the intersection of Randall Road and Spartan Drive.



#12 - Stearns Road

General location: From the intersection of Stearns Road and Randall Road proceeding East to the intersection of Stearns Road and Kirk Dunham Road.



#13 - Technology and Discovery Drive

General location: From the intersection of IL 38 and Technology Drive to the Intersection of Fabyan Parkway and Technology Drive.
