Residents are encouraged to register for an upcoming hazardous waste recycling event to dispose of certain hazardous household materials. The event will be held on June 5, 2021 from 8:00 AM to 3:00 PM at 306 N. River Street in Aurora.

At this event — made possible through a partnership of the Illinois Environmental Protection Agency, Kane County, DuPage County and the city of Aurora — you can dispose of your household cleaners, fertilizers, pesticides, auto fluids, oil-based paints and stains and much more.

The event is free and open to residents of Illinois.

#### Event guidelines:


- Place all materials in your trunk or back seat so workers can collect it and maintain social distance. Also please wear a mask while interacting with event workers.
- Business, institution and agriculture waste will NOT be accepted.
- Please carpool with neighbors to bring your hazardous waste materials for safe disposal.

- Please clearly label and safely package all waste materials and stay in your vehicle at event.

## Parks and Recreation Planning Webinar

The webinar discusses an approach to creating park systems that provide greater community benefits



Parks and recreation systems have evolved during the past two decades. No longer regarded as simply playgrounds and ballfields, parks and open spaces are being increasingly viewed as green infrastructure, with the potential to contribute to community resiliency and sustainability. To capitalize on this potential, the parks and recreation system planning process needs to evolve as well.

Dr. David Barth, AICP, ASLA, CPRP, outlined an approach to creating parks systems that generate greater economic, social, and environmental benefits.

Dr. Barth explains why parks and recreation systems should be regarded as elements of an integrated public realm and illustrated how these spaces can be designed to generate multiple community benefits.

# American Rescue Plan Act Support for State and Local Governments

CMAP has published an overview documenting the various types of assistance available to local agencies



The \$1.9 trillion American Rescue Plan Act (H.R. 1319) provides direct relief to state and local governments, and continues support for public transit agencies. The bill, which was signed into law in March, also provides additional relief in the form of grant and loan assistance for environmental justice, household utilities, housing, economic development, and small businesses.

CMAP staff recently updated their interpretation of the programs in the legislation. CMAP published a summary report meant to be used by local governments for informational purposes. Staff will update this overview as these programs are implemented in the coming months.

The report summarizes the various forms of assistance delivered through the Plan including:

- Direct State and Local Assistance
- Public Transportation Assistance
- Environmental Assistance
- Economic Development Assistance
- Small Business Assistance
- Housing Assistance
- General Assistance
