Annual Asphalt Rejuvenator Program Scheduled to Begin June 22nd

June 18, 2026 - The Kane County Annual Asphalt Rejuvenator Program is scheduled to begin the week of June 22, 2026, weather permitting. The program applies an asphalt rejuvenator to roads that were resurfaced within the last year to help extend the life of the pavement.

The process includes applying a rejuvenator liquid, allowing it to cure, placing sand on the treated roads for traction, and then sweeping up excess material following completion of the treatment. This preventative maintenance reduces oxidation of the asphalt and helps prevent water from seeping into the pavement, protecting against freeze/thaw damage during the winter months.

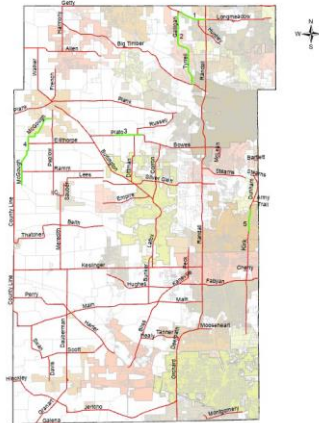
Work is expected to occur Monday through Friday between 7:00 a.m. and 4:00 p.m. Treatment operations will progress from location to location, and the schedule and sequence of work are subject to change based on weather and operational needs. Roadways included in this year's program are:

- Huntley Road
- Galligan Road / Tyrrell Road
- Plato Road
- McGough Road
- Kirk Road (9:00 a.m. to 3:00 p.m.)

Roadways will remain open during treatment; however, temporary lane closures may be necessary, and traffic may be reduced to a single lane with the use of flaggers. Motorists

should expect delays and are encouraged to use caution in work zones, watch for crews and equipment, and follow directions from flaggers.
