## Fourth of July Anti-DUI "No Refusal" Initiative Results in Three Arrests, One Search Warrant

**St. Charles, Ill. -** Kane County State's Attorney Jamie L. Mosser announced today that the July 4 No Refusal initiative, a collaborative effort of the State's Attorney's Office and Kane County law enforcement agencies, resulted in three arrests.

Fourteen law enforcement agencies participated, including police agencies from Aurora, Batavia, Carpentersville, East Dundee, West Dundee, Elburn, Elgin, Geneva, Maple Park, Montgomery, Pingree Grove, and St. Charles, in addition to Illinois State Police Troop 3 and the Kane County Sheriff's Office.

The No Refusal initiative was conducted from 10 p.m. on July 4, 2025 to 2 a.m. on July 5, 2025. During the operation, suspected intoxicated drivers were arrested, transported to a local police station, and asked to submit to a Breathalyzer or other chemical testing. If a suspect refused testing, they were informed by an assistant state's attorney (ASA) that a court order would be sought ordering them to comply. A suspect would then face additional charges if they continued to refuse testing.

Illinois courts have consistently held that a driver has no right to refuse chemical testing when probable cause exists that they are intoxicated and operating a motor vehicle

During the Fourth of July weekend initiative, the Kane County State's Attorney's Office obtained one search warrant pertaining to a motorist who initially refused to submit to chemical testing.

**State's Attorney Mosser said:** "It is deeply concerning that some individuals still choose to put lives at risk by driving under the influence. In just under two hours during this No Refusal initiative, law enforcement made three DUI arrests, highlighting just how vital these enforcement efforts are. Every impaired driving incident is preventable, and we remain committed to deterring this dangerous behavior. I want to thank DUI Unit Supervisors ASA Katy Flannagan and ASA Tyler Cox, as well as the dedicated law enforcement officers, dispatchers, the on-call phlebotomist, and everyone involved in ensuring the success of this operation. Their efforts are essential to keeping our roads and communities safe."

#### Aurora Police Department:

**Anibal N. Ramos**, age 52 (d.o.b. 07-31-1972), of the 300 block of Stuart Ave, Aurora, Illinois, Case No. 2025-DT-596. **Ramos** was arrested at 12:29 a.m. on July 5, 2025. He is charged with driving under the influence of alcohol with a BAC of 0.08 or more, improper lane usage, illegal stopping/parking where prohibited, operating an uninsured vehicle, and no proper evidence of registration. Ramos refused a preliminary breath test and other chemical testing. Ramos complied with chemical testing after a search warrant was obtained. His next court appearance is scheduled for July 30, 2025 at 9 a.m. in Courtroom 203 at the Kane County Judicial Center.

### Maple Park Police Department

**Christopher S. Siebens**, age 23 (d.o.b. 04-21-2002), of the 300 block of Fair St, Sycamore, Illinois, Case No. 2025-DT-622. **Siebens** was arrested at 1:32 a.m. on July 5, 2025. He is charged with driving under the influence of alcohol with a BAC of 0.08 or more, illegal transportation of alcohol, and improper lane usage. According to the charges, Christopher Siebens voluntarily submitted to chemical testing and had a BAC of 0.200. His next court appearance is scheduled for August 8, 2025 at 9 a.m. in Courtroom 203 at the Kane County Judicial Center.

#### Elburn Police Department

**Samantha R. Hoffman**, age 27 (d.o.b. 03-18-1998), of the 2000 block of Bella Dr, Pingree Grove, Illinois, Case No. 2025-DT-594. **Hoffman** was arrested at 2:26 a.m. on July 5, 2025. She is charged with driving under the influence of alcohol with a BAC of 0.08 or more, illegal transportation of alcohol, and expired registration. According to the charges, Samantha Hoffman voluntarily submitted to chemical testing and had a BAC of 0.249. Her next court appearance is scheduled for August 8, 2025 at 9 a.m. in Courtroom 203 at the Kane County Judicial Center.

The charges against these defendants are not proof of guilt. Each defendant is presumed innocent and is entitled to a fair trial in which it is the state's burden to prove guilt beyond a reasonable doubt.
