

Re: Petition #4666 – Proposed Solar Farm Adjacent to West Highland Acres Unit No. 2

We, the undersigned property owners and residents of West Highland Acres Unit No. 2 respectfully object to the approval of Petition #4666 for the development of a commercial solar farm on property located immediately west of our subdivision.

Our objections include, but are not limited to, the following:

1. **Adverse Impact on Residential Character** – The proposed industrial-scale solar installation is inconsistent with the established residential nature of our neighborhood and surrounding properties.
2. **Potential Decrease in Property Values** – The visual and perceived industrialization of the area could negatively affect market values of nearby homes.
3. **Environmental and Safety Concerns** – Concerns include possible glare, runoff, habitat disruption, fire, flooding and wind damage to panels.
4. **Incompatibility with the Kane County 2040 Land Use Plan:** Approval of this proposed solar farm would adversely — and in some cases drastically — conflict with the goals, objectives, and intended land uses outlined in the Kane County 2040 Land Use Plan, which emphasizes preservation of community character, protection of agricultural resources, storm water management and thoughtful land-use transitions..

We urge the Kane County Zoning Board of Appeals and the Kane County Board to **deny** Petition #4666
