

Re: **Recommendation against establishing mandatory
Multi-Township Assessment Districts following the 2020 decennial census**

Pursuant to the requirements of the Illinois Property Tax Code, a Supervisor of Assessments must make a recommendation for the adoption of Multi-Township Assessment Districts after each decennial census.¹

For the reasons that follow, **I recommend that no multi-township districts be adopted in Kane County following the 2020 decennial census.**

Background

A Multi-Township Assessment District (an "MTAD") consists of two or more contiguous townships which, for purposes of the Property Tax Code, make up a single administrative unit and elect a single Multi-Township Assessor for the administration of the property tax code.² The supervisors and clerks of the various townships within each MTAD make up the Multi-Township Assessment District Board of Trustees.³ Townships comprising an MTAD must be in the same county and contiguous to one another, "they share a common boundary line or meet at any point."⁴

MTADs can be established both on a voluntary and mandatory basis:

- Townships may voluntarily create an MTAD “by majority vote of each board of trustees of the townships.”⁵ I note in passing that Township Boards have the sole authority in establishing a voluntary MTAD, and neither Kane County nor the Illinois Department of Revenue have any role in such a process.
- An MTAD is mandatory for any township with a population of fewer than 1,000 persons.⁶

I also note in passing that the establishment (or subsequent dissolution) of an MTAD “is not an alteration of the boundaries of any township, a change in township lines, a division, enlargement, or consolidation of any township, or the creation of a new township.”⁷

No MTADs have been established within Kane County.⁸

Responsibilities of the Supervisor of Assessments

The Kane County Supervisor of Assessments must, by August 1, 2022, “prepare maps, by county, of the townships, indicating the number of inhabitants and the equalized assessed valuation of each township for the preceding year, within the counties under township organization, and shall distribute a copy of that map to the county board and to each township supervisor, board of trustees, sitting township or multi-township assessor, and to the Department [of Revenue]. The map shall contain suggested multi-township assessment districts for purposes of assessment.”⁹ These requirements exist even if no MTADs are proposed for the county in question.¹⁰

The map required map is attached to this memorandum as Exhibit A. **By way of this correspondence, I am informing you that no MTADs are proposed, as no Township in Kane County has a population of fewer than 1,000 persons.**

Responsibilities of the Township Boards

“Upon receipt of the maps, the boards of trustees shall determine separately, by majority vote, if the suggested multi-township districts are acceptable.”¹¹ **No mandatory MTADs are proposed, as no Township in Kane County has a population of fewer than 1,000 persons. Therefore, no further action by any Township Board is needed unless the Township Board believes the population amounts shown on the attached map are incorrect.** This process does not impact the ability of Townships to create voluntary MTADs.

Responsibilities of the Kane County Board

“In any dispute between 2 or more townships as to inclusion or exclusion of a township in any one multi-township assessment district, the county board shall hold a public hearing in the county seat and, as soon as practicable thereafter, make a final determination as to the composition of the district.”¹² **I note in passing that the County Board’s role is limited to the resolution of a dispute between Township Boards on this process. If there is no dispute, there is no further action to take.**

Responsibilities of the current Township Assessors

Except for the right of notice, no role for current Township Assessors is specified by the Property Tax Code.

Responsibilities of the Illinois Department of Revenue

The Department must be kept abreast of any actions taken on this topic, and it has certain responsibilities for recordkeeping; the details are found in the Property Tax Code.¹³

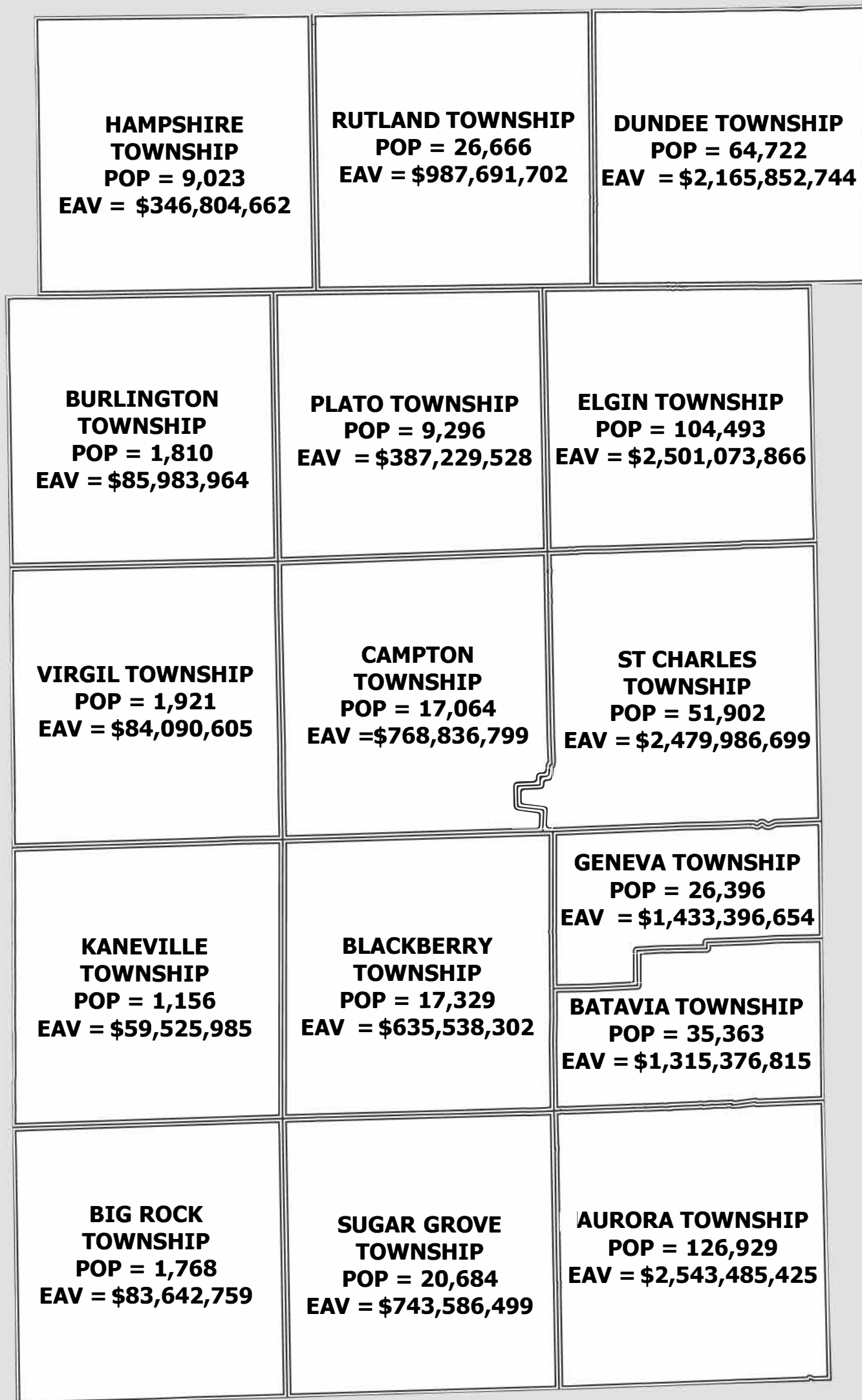

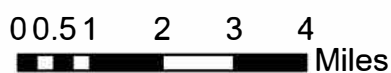
