ORDINANCE NO. 22 - 201

AMENDING SEC. 2-73 SALARIES OF ELECTED OFFICIALS

WHEREAS, pursuant to the requirements of 55 ILCS 5/2-3008 and 50 ILCS 145/2, the County Board has reviewed the salaries for the following offices: County Board Chairman, County Board Members, Sheriff, County Clerk, and Treasurer; and

WHEREAS, the County Board has determined that it is in the best interests of the County that the salary for the County Board Chairman remains unchanged at this time, as that position is not up for election in November, 2022, and no adjustments in salary can take effect during an incumbent's term under Illinois law; and

WHEREAS, the County Board has determined that it is in the best interests of the County that the salaries of County Board Members, for the terms of office to begin in December, 2022, should continue to be calculated on an annual, not a per diem, basis, and that such members should remain eligible for County health insurance benefits; and

WHEREAS, the County Board has determined it is in the best interests of the County that salaries for the Sheriff, County Clerk and Treasurer, for the terms of office to begin in December, 2022, should be adjusted to reflect the responsibilities of the positions and, in the case of the Sheriff's salary, to comply with newly enacted legislation; and

WHEREAS, Public Act 102-0699 was enacted on April 19, 2022, amending the Counties Code by adding Section 3-6007.5, 55 ILCS 5/3-6007.5, requiring (1) the salary of the County Sheriff of a non-home rule county to be not less than 80% of the salary set for the State's Attorney under 55 ILCS 5/4-2001; and (2) the State shall furnish 66 2/3% of the total annual salary to be paid by the Sheriff, and the County shall furnish 33 1/3% of the total annual salary; and

WHEREAS, Section 4-2001 of the Counties Code, 5 ILCS 5/4-2001, establishes the methods used to set the salary of the State's Attorney; and

WHEREAS, the County Board has determined that subsequent annual salary increases of 2% for the duration of the next term of the offices for the positions of Sheriff, County Clerk, and Treasurer are prudent; and

WHEREAS, as required by law, none of the salaries paid by the County to the Sheriff, County Clerk and Treasurer shall be reduced by any stipends paid by the State of Illinois, including without limitation the expected \$6,500 annual stipends to be paid by the State to each such officer in accordance with Section 4-6003 of the Counties Code, Section 4-6001 of the Counties Code and Section 3-10007 of the Counties Code, respectively.

NOW, THEREFORE, BE IT ORDAINED by the Kane County Board that the salaries of County Board Members, for the terms of office to begin in December, 2022, shall be calculated on an annual, not a per diem, basis, and that such members shall be eligible for County health insurance benefits; and

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Kane County Board that the Kane County Code, Section 2-73 Salaries - Elected Officials, is hereby amended as follows (underline indicates insertion of text; strike-through indicates deletion):

F. The salary of the members of the County Board is hereby fixed as follows:

10. Effective December 5, 2022, twenty-five thousand dollars (\$25,000) per annum payable in bi-weekly installments.

G. The salary of the Kane County Sheriff is hereby fixed as follows:

10. Effective December 1, 2022, one hundred sixty thousand dollars (\$160,000) per annum payable in bi-weekly installments.

11. Effective December 1, 2023, one hundred sixty-three thousand two hundred dollars (\$163,200) per annum payable in bi-weekly installments.

12. Effective December 1, 2024, one hundred sixty-six thousand four hundred sixty-four dollars (\$166,464) per annum payable in bi-weekly installments.

13. Effective December 1, 2025, one hundred sixty-nine thousand seven hundred ninety-three dollars (\$169,793) per annum payable in bi-weekly installments.

Notwithstanding the above provisions, in compliance with 55 ILCS 5/3-6007.5, beginning December 1, 2022, the salary of the Kane County Sheriff shall be adjusted upwards on an annual basis to the extent necessary so that the Sheriff's salary is not less than 80% of the Kane County State's Attorney's salary set by the State of Illinois under 55 ILCS 5/4-2001.

H. The salary of the Kane County Clerk is hereby fixed as follows:

10. Effective December 1, 2022, one hundred five thousand dollars (\$105,000) per annum payable in bi-weekly installments.

11. Effective December 1, 2023, one hundred seven thousand one hundred dollars (\$107,100) per annum payable in bi-weekly installments.

12. Effective December 1, 2024, one hundred nine thousand two hundred forty-two dollars (\$109,242) per annum payable in bi-weekly installments.

13. Effective December 1, 2025, one hundred eleven thousand four hundred twenty-six dollars (\$111,426) per annum payable in bi-weekly installments.

I. The salary of the Kane County Treasurer is hereby fixed as follows:

10. Effective December 1, 2022, one hundred five thousand dollars (\$105,000) per annum payable in bi-weekly installments.

11. Effective December 1, 2023, one hundred seven thousand one hundred dollars (\$107,100) per annum payable in bi-weekly installments.

12. Effective December 1, 2024, one hundred nine thousand two hundred forty-two dollars (\$109,242) per annum payable in bi-weekly installments.

13. Effective December 1, 2025, one hundred eleven thousand four hundred twenty-six dollars (\$111,426) per annum payable in bi-weekly installments.

The sum salaries indicated in subsections B, C, D, G, H, and I of this section shall not be reduced by any stipends paid by the State of Illinois, including without include any funding from the state of Illinois limitation the \$6,500 stipends expected to be received from the State of Illinois for the respective offices under: Section 3-40 of the Property Tax Code, Section 4-20 of the Property Tax Code, Section 3-10007 of the Counties Code, Section 4-2001 of the Counties Code, Section 4-6001 of the Counties Code, Section 4-6002 of the Counties Code, Section 4-6003 of the Counties Code, and Section 27.3 of the Clerks of Courts Act.

~~J. Compensation for the vice chairperson is hereby fixed as follows:~~


- ~~1. Effective December 15, 1999, seven thousand five hundred dollars (\$7,500.00) per annum payable in monthly installments.~~
- ~~2. Effective December 1, 2004, the vice chairperson shall be compensated up to ten (10) per diems per month in his or her capacity as vice chairperson. This amount shall be in addition to any per diems received in a capacity other than vice chairperson. There will be no additional salary for the vice chairperson.~~

~~K.J.—In addition to the other compensation set forth in this section, each elected official shall be entitled to receive the benefits of any comprehensive health insurance/HMO benefits that are available to Kane County employees who are not in a collective bargaining agreement. If the provisions of article VII, section 9(b) of the 1970 constitution of the state would prohibit an elected official from receiving this benefit set forth in this subsection, then that elected official would receive the benefit mandated by the constitutional provision for that year.~~

~~L. Effective December 1, 2000, per diem payments shall be calculated in the following manner: Any county board member who is in attendance at any meeting or special assignment as described in article II, section 2-49 of this chapter shall be entitled to thirty dollars (\$30.00) per diem. However, any county board member who on any single day attends a meeting or a special assignment and attends another, but separate, meeting or special assignment shall be entitled to an additional thirty dollars (\$30.00) per meeting or special assignment.~~
