5. Presentations/Discussion**A. Drug Court Rehabilitation Update (Judge Marmarie Kostelny & Staff)**

Referencing a PowerPoint presentation Judge Kostelny provided an update on the current Kane County Drug Rehabilitation Court program highlighting its effectiveness, progress and successes. The reduction of recidivism is paramount. Of those who entered the Kane County Drug Court program as of April 13, 2015, 48% were heroin addicts and 19% were cocaine addicts. In 2014, the program was awarded a grant of \$1.2 million for a 3-year period. All board members were invited to attend drug court graduation May 6, 2015, at Geneva High School.

B. Foreclosure Mediation Update (Chief Judge Brawka & Staff)

Referencing a PowerPoint presentation Kane County Residential Mortgage Foreclosure Mediation Program Coordinator Kevin Malone and Paralegal Faviola Guzman provided highlights of the first year program results in direct response to the foreclosure crisis in Kane County. The program was launched through a grant from the Attorney General's Office. The goals are judicial efficiency, increased access to justice and provide homeowners and lenders an opportunity to work out the foreclosure to benefit homeowners, lenders and taxpayers of Kane County. The program helps by providing space where the lender and borrower can meet, by providing resources for borrowers to work with lenders (HUD), and by arranging the mediation session. Generally, the majority of foreclosures are occurring in the more western parts of the county. Data is constantly monitored and evaluated. Target populations are being served and bilingual documents are available in both English and Spanish. Translation services are also available to include; Polish, Laotian, sign language and others. Income rates being served include the \$20,000 - \$74,000 salary range, primarily the middle class. Low income populations are also being served. The overall satisfaction with the outcome of the program is 70%.

C. Composition of Kane County Resolution to Support Reform in Springfield

Chairman Lauzen explained this is considered to be a workshop to put together agreed upon items that will be presented to Springfield in a positive manner and this is the hallmark of the legislative committee to arrive at a solution that is not divisive. Chairman Lauzen showed a series of slides and initial discussion by committee was held on each.
