- Do not bring any of the items on the NOT Accepted list as we cannot take them and it slows down the line.

## ITEMS ACCEPTED

- Acids
- Adhesives
- Aerosol products
- Antifreeze
- Auto fluids
- Ballasts (PCB)
- Batteries – sump, power tool & household sizes (**NO automotive/ lead-acid batteries**)
- Blacktop sealer - oil based
- Cleaning products
- Cooking oil
- Corrosives
- Drain cleaners
- Fluorescent bulbs (*tubes and CFLs*)
- Gasoline & oil/gas mixtures
- HID lightbulbs (*headlight bulbs*)
- Hobby & photo chemicals
- Lawn chemicals
- Medications (**NO controlled substances**)
- Mercury-containing devices (*thermostats, etc.*)
- Motor oil
- Oil Paint (*Oil-based paints, stains, varnishes only, NO latex paint*)
- Paint Thinners
- Pesticides, poisons, herbicides, insecticides
- Pool chemicals
- Resins, glues
- Solvents

## DO NOT BRING - Items NOT Accepted

- **LATEX PAINT** (*Latex Paint is not hazardous and can safely be dried and discarded as trash, or brought to a Kane County Paint Recycling event on 7/10/21 or 9/11/21; 8am-noon @ 540 S Randall, St. Charles, or participating Ace hardware stores. Cost: \$3/gal can. See [countyofkane.org/recycling](http://countyofkane.org/recycling)*)
- **Acetylene cylinders**
- **Agricultural wastes** (*anything used in a commercial application to grow something that will be sold*)
- **Ammunition, explosives or fireworks**
- **Biological & medical wastes** (*biohazards*)
- **Business & commercial sector wastes**
- **Farm machinery oil**
- **Fire extinguishers**
- **Foam cylinders (Part A/Part B)**
- **Institutional wastes**
- **Lead-acid (auto) batteries**
- **MAPP gases**
- **Oxygen tanks**
- **Pharmaceuticals** (*controlled substances*)
- **Propane tanks**
- **Radioactive material**
- **Smoke detectors**
- **Syringes/Needles**
